







The tourism sector should be prioritised and mainstreamed in the programme linked to the green and blue economy and innovation



Encourage the exchange of experiences of projects among themselves to create synergies and transfer good practices and results.



The key factor for the success of projects in African countries is to take into account the needs expressed by these partners: public health, sustainable tourism, agriculture, biodiversity and institutional capacity.



## Policy Objective 1: A Smarter Europe



Importance of cooperation in the area of health (innovation, health research, advanced treatments) between the regions and countries of the programme



Encouraging the digital transformation of tourism as a method to promote a sustainable tourism model



Digitalization of services to improve efficiency, optimise logistics and minimise the need to move people (also related to the reduction of greenhouse gases - OP 2)



Promote research and increased training in the agricultural field in order to implement sustainable agriculture



Fostering Digital Skills in Society: promoting the development of training programmes (general population and productive sectors) in direct relation to the strategic needs of the territories



Strengthening research infrastructures, technological development and innovation, with emphasis on the priority lines described in the RIS3.



Policy Objective 2: A greener Europe



Greater emphasis on the blue economy: conservation, valorization and sustainable use of the ocean and its resources, blue infrastructures, circular economy-aquaculture



Water sector: Actions for the efficient use of water resources and the fight against drought in the face of climate change. Development of a specific line related to water (quality and improvement, efficient use, savings) in all its variants (groundwater, water supply, irrigation, purified water) and especially marine water due to discharges and environmental impact



Importance of research and action plans on seismic and volcanological risks



### Policy Objective 3: Better Interreg Governance



Promote the continuity of successful projects in order to consolidate their transfer to other sectors and to society



Promote cooperation and exchange between projects to create synergies, transfer experiences and results and achieve maximum efficiency, avoiding the dispersion of efforts that should be concurrent



Capacity building in third countries in priority health areas that have an impact on improving public health



Development of the institutional capacity of African countries: efficiency of institutions, training of human capital, programmes for the exchange of good practices, creation of regional networks, etc.
